**Subject:** Weekly Report

1. **DuPage County Field Court Discussion** – I attended the County Board Finance Committee meeting on Tuesday morning to hear the discussion on this issue. Though it was an often confusing discussion with competing points of view the general consensus was that communities interested in a local field court would need to pay for the privilege. Further discussions have occurred and we expect to have an update for the Board at an upcoming meeting.
2. **DuPage County Cannabis Decision** – The DuPage County Board voted on Tuesday to ban cannabis dispensaries in unincorporated areas. Though not likely, this might have affected Clarendon Hills due to unincorporated areas adjacent to the south side of 55<sup>th</sup> Street.
3. **Budget Update/Board Workshop Schedule** – As a reminder, the Budget Workshop meeting with the Board will take place at 5:30 p.m. on Monday November 4. We plan to post an agenda for regular meeting actions at 7 p.m. that same evening. Budget materials will be sent out next week.
4. **Westmont Cannabis Discussion** – The Westmont Village Board met last night to discuss the status of cannabis sales. As of now, it appears they plan to allow dispensaries in certain districts with a special use application. The areas where this might be allowed include most of the areas adjacent to Clarendon Hills north of Ogden, except for areas immediately north of the Stonegate neighborhood. There are some areas south of Ogden that could be allowed, but NOT the Standard Market property.
5. **Chamber Halloween Walk** – The Chamber of Commerce Halloween Walk is tomorrow (Saturday) in the downtown area from 11 a.m. to 2 p.m. Bring the kids and enjoy this event!
6. **Free Leaf Pickup** - As a reminder, leaves (only – no grass!) can be placed in yard waste cans or paper yard waste bags and placed out on Tuesdays with your other garbage without a sticker. Other yard waste (grass clippings, sticks, weeds, etc.) still require a sticker. This is in effect for the months of October and November.

1. The Burlington Water Tower has been painted and crews are starting on adding the village logo.
2. Salt spreaders and plows were installed on the smaller trucks to ensure everything is operational and no parts need to be ordered.
3. We began recruitment for a Maintenance Worker.
4. I attended a meeting of the DuPage Mayors and Managers Transportation Committee. Additionally, there was a mandatory training session for municipalities applying for or receiving federal transportation dollars. The Village will be receiving such monies when the pedestrian bridge adjacent to Eastern Avenue is replaced.
5. Crews performed work at the Richmond Educational Garden area to prep the area for brick pavers to be installed.
6. Additional culvert maintenance was performed. New landscaping went in at the Ogden Avenue entrance to Stonegate. This was jointly funded by the neighborhood and the village. Public Works will be watering the new plants until they are established.
7. A fire hydrant was replaced on Holmes south of 55<sup>th</sup>.
8. Trees were measured for winter trimming by the Village's contractor.
9. IDOT contacted us to schedule a preconstruction coordination meeting for the roadway and landscaping improvements that will occur north of the Burlington Northern Tracks and mostly east of Prospect. We will be meeting on November 11<sup>th</sup> at IDOT Headquarters.
10. ComEd performed a number of pole replacements. One set was in advance of the train station work. The other area was on Burlington to allow for one of the businesses to expand.

**Significant traffic and criminal activity during the past week.**

On October 20, 2:47am, officers responded to a fatal car crash on southbound Rte. 83. A wrong way driver collided head-on with a southbound vehicle. Two people died in the crash. One person remains in critical condition. The wrong way driver was taken into custody and charged with two counts of Aggravated DUI Causing Death (Class 2 Felony) and one count of Aggravated DUI Causing Great Bodily Harm (Class 4 Felony). Investigation in ongoing.

On October 21, 4:35pm, officers responded to the Jewel for a retail theft. A male subject stole liquor and fled the parking lot in a black car. Store personnel advised the same subject has stolen liquor in the past. Pending.

On October 21, 5:55pm, officers assisted a resident, who was receiving harassing phone calls.

On October 24, 9:30pm, officers responded to the Jewel for a retail theft. The offender fled with various goods from the store. Officers were able to track down the offender. Charges Pending.

1. Fire Prevention Bureau Activity during the past week.
  - Eleven (11) Fire/Life Safety Inspections were conducted.
2. Training Report:
  - Wednesday evening twenty one (21) firefighters attended fire suppression training. Classroom instruction on vehicle extrication along with vehicle extrication training on a surplus/junk car.
3. Emergency Medical Services Report:
  - No report.
4. Clarendon Hills/Hinsdale FD sharing of services report:

5. Emergency Management Report:

6. Du-Comm Report:

7. Vehicle maintenance:
  - Captain Bonser performed some minor in house vehicle maintenance on Medic 86.
8. Incidents of Interest:
  - Friday, October 18<sup>th</sup> at 3:25 PM. Medic 86, Squad 86, Hinsdale Engine 84 and Medic 84 responded for a vehicle accident with injuries on Rt. 83 southbound at Chicago Ave. One (1) injured patient transported to a local hospital.
  - Sunday, October 20<sup>th</sup> at 2:47 AM. Medic 86, Squad 86, Engine 86, Ladder 86, Hinsdale Engine 84 and Medic 84 responded for a head on vehicle accident on Rt. 83 southbound south of the BNSF RR Bridge. Upon arrival Medic 86 found five (5) very severely injured patients in two (2) vehicles. Additional ambulances were called and Westmont Medic 182, Westmont Medic 183, Tri State Medic 122, Oak Brook Medic 94 and Western Springs Medic 1714 responded. Paramedic in charge Ryan Lange performed triage on all patients, contact the hospital on telemetry and advised the hospital of the number of patients and their severity. Three (3) Red (severe) patients were transported to Good Samaritan Hospital Level I Trauma Center and two (2) yellow (moderate) patients were transported to Hinsdale Hospital Level II Trauma Center. Two (2) of the patients transported to Good Samaritan Hospital died from their injuries in the hospital. One (1) patient remains in critical condition at Good Samaritan

Hospital. Later during this incident, One (1) Clarendon Hills firefighter was transported by ambulance to Hinsdale Hospital for a hand injury. During this incident Downers Grove Medic 102 and Westmont Engine 181 covered the station in Clarendon Hills in case there was another call in the village.

9. Mutual Aid Calls:

- Clarendon Hills Medic 86 responded to four (4) EMS calls in Hinsdale.
- Westmont Medic 182 responded to two (2) EMS calls in Clarendon Hills.
- Hinsdale Medic 84 responded to four (4) EMS calls in Clarendon Hills.

10. Fire/Rescue/EMS calls:

- The Hinsdale Fire Department responded Automatic Aid to Clarendon Hills seven (7) times.
- The Clarendon Hills Fire Department responded Automatic Aid to Hinsdale seven (7) times.
- The fire department responded to thirty one (31) emergency calls.
