Subject: Weekly Report

1. **DMMC Regulatory Committee** – I attended this meeting on Wednesday afternoon. The primary topic was a long discussion with other DuPage communities regarding the 5G issue. There is generally universal concern with how it is being rolled out. We discussed potential legislation and other matters. This type of discussion, in this and other forums, will continue.
2. **“White Stakes” in Parkway Update** – Related to 5G, the stakes that showed up around town without announcement have been confirmed to be marking for potential Verizon poles. Permit applications have not yet been made. When they are we expect to review them thoroughly and respond accordingly. I have a proposal for the Village Board to review at the next meeting to provide professional assistance with this review.
3. **Du-Comm Board of Directors Meeting** – I attended this meeting on Tuesday morning in Wheaton. Regular business was conducted including the approval of the budget. This budget includes the reduced amount we were able to negotiate for fire dispatch services. A major initiative is to review fund balance policies to determine if there are ways to further reduce rates using existing reserves.
4. **Financial Forecast Forum** – I attended this event on Friday (today). This presentation, sponsored by the Illinois City Management Association and others, is an opportunity to hear from numerous presenters regarding national and local economic trends. This is a valuable way to keep track of market forces which can help us make appropriate policy recommendations.
5. **Snow and Ice Control** – The Public Works Department is continuing to address the current snow/rain event. So far they are doing a great job.
6. **Village Employment** – The Village is continuing recruitment for the Senior Accountant position and Police Officers.

1. The snow that was missing for most of December decided to show up this week. While accumulations were low, they have been frequent. Crews were out salting and in some instances plowing on Friday night, Saturday morning, Sunday morning, Monday morning, Thursday morning, Friday morning and we expect to be back tonight and/or early Saturday morning.
2. A water service became separated from the main on Eastern Avenue on Thursday afternoon. A new water service was installed that afternoon.
3. The temporary cellular towers were taken down this week from the Burlington location.
4. Miscellaneous items completed this week include a number of JULIE locates, replacing hoses on the end loader, replacing bolts on the plow blades and taking delivery of more salt.

Subject: Weekly Department Report 2020-01

1. Fire Prevention Bureau Activity during the past week.
 - All inspections for 2019 were completed.
 - Inspections for 2020 have begun.
2. Training Report:
 - Wednesday evening nineteen (19) firefighters attended fire suppression training. Firefighters trained on the critique of a recent fire and then pre planned several occupancies in the village.
3. Emergency Medical Services Report:
 - No report.
4. Clarendon Hills/Hinsdale FD sharing of services report:
 - No report.
5. Emergency Management Report:
 - No report.
6. Du-Comm Report:
 - On Tuesday, January 21st, I attended the quarterly meeting of the Du-Comm Board of Directors. Normal business was conducted along with the passage of the 2020/21 budget which goes into effect on May 1, 2020.
 - During the past 2 weeks there have been several CAD failures and also one 911 failure for the entire county. Actions were taken on both of these issues to prevent them from happening in the future.
7. Vehicle maintenance:
 - All six (6) vehicle batteries and cables were replaced on Engine 86 using in house personnel to assist in the repairs.
8. Firefighter Paramedic Chris Fennell has been promoted to the rank of Lieutenant in the fire department. Congratulations Chris!
9. During the calendar year of 2019, the fire department responded to 1,147 emergency calls. In 2018 the fire department responded to 1,031 Emergency calls. This represents about an 11% increase of calls in 2019. We are now in the process of compiling data and information for the 2019 Annual report which should be completed in the next 45-60 days.

10. Incidents of Interest:

- Tuesday, January 21st at 11:18 PM. The fire department received a call on the non-emergency line at the station from a motorist that there was some type of fire on 55th St. between Western Ave. and Holmes Ave. Soon after that Du-Comm started receiving 911 calls of a fire in the area of 55th and Clarendon Hills. Clarendon Hills Ladder 86, Medic 86, Engine 86, Squad 86, Chief 86, Deputy Chief 86 and Hinsdale Engine 84 responded. Upon arrival Ladder 86 and Medic 86 located the fire at 273 and 275 Churchill involving two (2) garages and the back of one of the houses. Because of this of the volume of the fire involving possible three (3) structures, a MABAS Division 10 Box Alarm was called immediately bringing in fire departments from Westmont, Western Springs, Darien Woodridge, Pleasantview, Oak Brook, Downers Grove, York Center and Tri State. Firefighters quickly had three lines on the fire and secured two water sources from fire hydrants on Churchill and also 55th St. Firefighters had to cut a large hole in the 55th St. sound wall to better access the fire from the south. During the fire ComEd wires above the garage burned through and fell onto the ground near firefighters creating a hazard for them. Normal precautions were taken for safety. ComEd was also called immediately. One (1) garage at 275 Churchill was completely destroyed along with two (2) cars that were inside the garage. The garage at 273 Churchill had outside damage to the south side of this garage. The houses at 275 and 273 Churchill were protected by firefighters and no damage to these houses occurred because of their actions. The cause of the fire is still under investigation. Total damage is estimated to be about \$100,000.

11. Mutual Aid Calls:

- A MABAS Division 10 Box alarm was called on January 21st which brought in nine (9) fire departments to assist with a structure fire.

12. Fire/Rescue/EMS calls:

- The Hinsdale Fire Department responded Automatic Aid to Clarendon Hills six (6) times.
- The Clarendon Hills Fire Department responded Automatic Aid to Hinsdale two (2) times.
- The Fire department responded to twenty six (26) emergency calls in the past 7 days.
