- **Small Cell Wireless Update** – Several updates regarding this issue.
 - On Tuesday, the Village received JULIE locate requests from a known Verizon surveyor for about a dozen locations throughout town. This is common practice to conduct while design/engineering is ongoing and does not necessarily mean anything is imminent.
 - On Friday, we started discussions to look at potential updates to our municipal and possibly zoning code regarding this issue.
- **ACS Cloud Server** – Maureen Potempa and I met with our implementation team for moving our old IBM mainframe to a cloud based service. Testing continued this week. The project seems on track to be completed next month.
- **Special Events Committee**: The committee met on Tuesday night. The main topic was making recommendations for possible music acts. Issues regarding the format of this Committee are included on the agenda for Monday night.
- **Village Hall Updates**: Director Ungerleider and I met with PSI to look at energy efficiency updates at Village Hall. Currently, our building has old windows and an HVAC system that is at the end of its life, so we are exploring ways to address the issues comprehensively.

1. **Downtown Revitalization Project/Train Station Improvements.** Next week ComEd is expected to redirect the overhead power lines along platform to make way for the retaining wall construction. Once completed we will be able to continue excavation along the inbound platform and then the construction of the new retaining wall and shelter system. Project updates can be found at www.clarendonhills.us/dtrupdate.
2. **Downtown Tax Increment Financing (TIF) District.** Last Wednesday evening the Economic Development Commission reviewed the Downtown TIF report and other municipal incentive program programs. During the next 45 to 60 days the EDC will be developing a draft policy statement regarding the use of TIF financed incentive programs for Village Board consideration. 3. **Permits.** So far in February the Village has issued nine (9) building permits having a total reported construction value of \$138,232.
