Message from the President

Hello Neighbors,

As we look forward to spring, you may have noticed that the Village has begun to work on improving our downtown, starting with the train station. While I have written in depth about the \$11.5 million dollar public investment (over half of which is grant funded) we are making to the downtown revitalization project, I haven't talked about all the partners we are working with.


On February 13th, I attended the Economic Development Summit in the heart of our downtown. The Mike McCurry Group, a local real estate brokerage firm, hosted the event which was attended by our Chamber President Derek Berg, Economic Development Commission Chair Don Price, Village Staff, our business owners, our property owners and various representing real estate brokers. Ultimately, it will be our partners that create and attract the businesses, and build the properties that will make our downtown a regional destination. It was exciting to get everyone in the same room and talk about our strategies to grow and renew our downtown. Our Village's greatest resource is our people. We are blessed with a group of smart people that are passionate about our Village. I left the meeting excited for our future, in both announced projects (including three major projects on Burlington) and those still waiting on the drawing board yet to be finalized. While I know that government is not always the answer, I am confident that we will not be the barrier that stops needed development in our downtown, and we are ready to partner with the private sector to make necessary investments.



The Village continues to do everything in its power to work on the 5G issue. I, along with our Village Staff, have attended numerous meetings, town halls, and talked to countless residents concerned with the placement of 5G equipment within our Village. The Village Board took proactive action by updating our design standards, hiring a consultant to review any permit applications and recently engaged a communication specialist/lobbyist to advance the issue at the state level demanding the return of local control. This is a fast evolving issue, so to stay up to date please go to clarendonhills.us/5G and click the "Notify me" button at the top of the page. You will be prompted to sign up to get contacted anytime we have updates regarding this issue.

The 2020 Census is starting on April 1st. It is very important for our community that we have a complete count. The Census informs not only federal funding, but also all of our state shared revenues. Every dollar we get in those revenues is one less that we need to put on the property tax bill, so please take the couple of minutes needed to fill out your census. All the data is secure and will be anonymous.

Hang in there, spring is coming. See you around town!



Where do your property taxes go?

We hope you find this information helpful in interpreting the true value and purchasing power of the property taxes you pay. As you can see from the chart, the Village of Clarendon Hills portion of your tax bill is just 11% of a property owner's real estate tax bill that funds the Village's core services. The Village continues to provide outstanding value for your tax dollars by keeping the streets and public areas neat and well maintained, providing police and fire protection, maintaining reliable water service, and doing these efficiently as possible. As the chart illustrates, the remaining 89% supports the various school districts, Park District, DuPage County, and Downers Grove Township as illustrated below.



Tax Levy

Property taxation can be confusing. The property taxes that you will be paying in 2020 are for what is called the "2019 Tax Levy Year".

Tax Rate

The tax rate is the result of dividing the tax levy by the assessed value and multiplying that number by 100. It is the common factor applied to a property's billing value to determine their tax contribution. Given the aforementioned estimated assessed value and the recommended tax levy, the Village's 2019 tax levy rate (exclusive of the Library) is estimated to 0.6804, a decrease of 0.0142 from the prior year.

The estimated increase in the Village's 2019 equalized assessed valuation (EAV) would be the sixth increase since the 2013 levy as the overall EAV declined in levy years 2010 through 2013. On the following page is a ten-year history of the Village's tax rates and assessed valuations.

ESTIMATED 2019 LEVY YEAR PROPERTY TAX BILL

Based on an average home value of \$500,000 in Clarendon Hills, taxes paid to the Village in 2019 would be \$1,093. This estimate assumes a residential exemption of \$6,000.

**Census
2020**



The Census is mandated by the Constitution and conducted by the U.S. Census Bureau, a nonpartisan government agency. Participation is required by law. But more importantly the census count determines the number of representatives in Congress for each area. It also determines how federal funding is distributed over the next decade. Funding for highways, public transportation systems, grants that support teachers and educational programs, wildlife restoration, housing assistance for seniors, medical programs, underground water source protection and several other important programs.

Fun facts: The United States first census was in 1790. There were only 13 states. At that time 650 US marshals and assistants went by horseback and foot to record census answers on parchment and animal skins. In 1790 Census day was August 2nd.

A lot has changed since 1790 but one thing remains the same; residents matter.

Be sure to get counted in 2020!

Here's the timeline for the 2020 Census.

- Mid March - households will begin receiving official Census Bureau mail with detailed information on how to respond to the 2020 Census online, by phone, or by mail.
- April 1st - this is National Census Day. You respond to the census questions as to where you live as of this date April 1, 2020.
- May - the Census takers will begin visiting homes of residents that have not responded to the 2020 Census.
- December - the Census Bureau will deliver the apportionment counts to the President and Congress as required by law.

Political signs

Just a reminder, that per Village Code signage on public right of way is prohibited. In addition, Political signs shall not exceed six (6) square feet in area, shall not be illuminated, and shall be confined within private property. (Ord. 93-04-04; and Ord. 10-09-27; rev. Ord. 19-10-26).

Composting

Clarendon Hills residents have the option to sign up for organics composting with Republic Services. This program is offered annually from April 1 through November 30. Residents must contact Republic Services to purchase a 65 or 95 gallon container (\$140/ \$180 per season) to be used for organics composting and yard waste only. Organics composting will be collected each Tuesday along side your regular waste can. To participate in this program residents are required to contact Republic Services at 708-345-7050 or emailing your request to newtoter@publicservcies.com.

Accepted food items:

- **Fruit and vegetables**
- **Meat (no bones)**
- **Bread and crackers**
- **Pasta**
- **Dairy products, cheese, yogurt (no liquids)**
- **Coffee grounds**
- **Egg shells**

Prohibited items:

- **Beverages/Liquids**
- **Bones**
- **Plastic, foam, rubber bands and labels**
- **Pet waste and diapers**
- **Servingware such as plates, cups, flatware**
- **Paper products and plastic wrap**
