1. The Park Avenue tank re-coating project is in the home stretch. All exterior coating, including the Village logo, is complete. Some work on the cathodic protection system will occur in the next week along with the start of the final inspection process. Barring any unforeseen issues, we anticipate having the tank back in service by June 22nd.



2. The 2018 Road Improvement program trundles onward. The sewer subcontractor is making slow progress. This work will continue throughout next week primarily along Norfolk, then Tuttle and then Oxford. Shoulder work will not begin until the week of the 18th.
3. Tree planting is underway today and will continue on Monday. 84 trees will be planted.

1. **Development Update.** 88 Park sidewalks, street lights, and planters have been installed. Installation of underground irrigation and landscaping, including parkway trees, are underway. 88 Park's general contractor will be assisting the Village with hanging village streetlight banners before Daisy Days.

Band & Wire Orthodontics' remodel of 433 Ogden is almost complete and ready for a grand opening later this month.

2. **ZBA/PC - Zoning Ordinance Modernization Project.** The ZBA/PC's next meeting will be a special meeting on Thursday, June 21, 2018, at 7:00 pm. More information and the working draft of the proposed new zoning ordinance can be found at www.clarendonhills.us/zomp.
3. **Downtown Design Review Commission (DTDRC).** Last Tuesday evening, the DTDRC reviewed a proposal by Zablers Design Jewelers for the complete renovation of their storefront. The DTDRC provided Mr. Zabler direction and asked that he revise his proposal for review and approval at a later date. A copy of Mr. Zabler's facade renovation proposal is included in the 6/5/2018 DTDRC Agenda packet posted at www.clarendonhills.us/dtdrc.

That same evening the DTDRC reviewed the updated concept plans for the new train station and shelter project. These plans are also available in the 6/5/2018 DTDRC Agenda packet posted at www.clarendonhills.us/dtdrc. At the conclusion of the meeting the Commission unanimously recommended the Village Board proceed with the plans as presented.

4. **Building Code Update.** The Village is preparing a comprehensive update to its Building Codes and related amendments. Review needed for the proposed building code update continues as planned. More information about this code review can be found at www.clarendonhills.us/buildingcodeupdate.
5. **Richmond Education Gardens & Apiary.** On Monday afternoon, a group of Walker School 5th Graders and their teachers walked to the Gardens to learn about rainwater harvesting, bees, worms and composting. Special thanks goes out to Erin Kennedy of SCARCE for bringing her worms and compost lessons. This is the third year Walker School has made this trek to the Gardens before the end of the school year.
6. **Permits.** So far in June, the Village has issued seven (7) permits having a reported combined construction value of \$89,500. The monthly permit report for May is posted at www.clarendonhills.us/bp by early next week.
