Subject: Weekly Report

- Flash Flood Watch** – As of this writing, a flash flood watch is in effect for the area from 7 p.m. tonight until tomorrow (Saturday) afternoon. Police and Public Works departments are aware of this concern and are prepared to come in overnight or tomorrow if need be, with particular emphasis on monitoring the Chestnut Alley area.
- Work at Village Hall** – You may have noticed extensive work being performed in front of the Village Hall on Wednesday and Thursday. Unfortunately, in the midst of working to install a line for a new security camera, we pulled up and cut our own fiber optic line which provides internet and phone services to the Village Hall and Library. Proxit, our IT consultant, responded and provided an alternative source until the line was repaired. Repairs to bring the regular system back up were completed by Thursday afternoon.
- Fire Department Open House** – The Fire Department has been busy this week preparing for their annual Open House which is to be held, Saturday, October 6, 2018 from 11 AM to 2 PM. The hope is that the weather will cooperate long enough for the community to enjoy the safety demonstrations, see the fire trucks, meet our firefighters, and Sparky the fire dog!
- Planting Partners** - The beautiful zinnias in the planting beds have been pulled to make room for the fall planting of mums. Although we hated to see them go, it was time with the upcoming weather.
- Meeting with Republic Services Representatives** – Assistant to the Manager Nickell and I met with Republic to discuss our contract for rubbish, recycling and yard waste disposal. We looked at various options for providing service. The existing agreement ends in June of 2019. We are planning to discuss the status with the Board at the October 15, Meeting.
- Finance Committee Meeting**– The Finance Committee is scheduled to meet on Tuesday to review capital projects for the 2019 Budget. The intent is to develop questions or concerns that can then be discussed at the full Board budget review meeting later in October.

7. **Public Works Interim Director Update** – As expected, Bill Sprague began his tenure as Interim Director this week. John Heinz, as the back-up, has also been involved. So far it is working out well.
8. **Public Works Director Process Update** – As reported previously, ads have been in relevant professional locations for a few weeks. We expect to review resumes we have received over the next few days with the possibility of first interviews to take place over the next two weeks. We will keep you informed.

Recent events and training:

- Several officers completed on-line training
