1. **DMMC Meeting with New Legislators** – Village President Austin and I attended a meeting on Wednesday morning, the intent of which was to provide an opportunity to meet with local State legislators. We were pleased to meet with Representative Mazzochi and newly elected Senator Suzy Glowiak. This was a great opportunity to establish communication and discuss areas of local concern such as the possibility of consolidation of public safety pension systems.
2. **I-294 Report Meeting** – I attended a meeting on Thursday evening held by DuPage County to discuss their “I-294 Central Tri-State Travel Demand Analysis”. The basic intent of this study is to allow interested local parties to consider the possibility of additional access or exit from I-294 and the potential impact on local traffic. Potential projects include ramps at 55th Street, 31st Street and Cermak Road. Potential impact on Clarendon Hills, should any of these projects go forward, is limited with potential decreases or increases in traffic on Ogden Avenue and/or 55th Street. This will of course be a work in progress.
3. **Chestnut Alley Design Review** – Staff reviewed potential design elements prepared by Burke Engineering for the Chestnut Alley. We plan to bring a recommendation to the Public Services Committee in mid-January for review and referral to the Village Board.
4. **Recruitment Efforts** - The Village is currently accepting applications for the full-time position of Maintenance Worker I with the Public Works Department. For more information on this position and to learn how to apply, visit www.Clarendonhills.us/employment.
