

**ORDINANCE NO. 20-01-01**

**AN ORDINANCE AMENDING ORDINANCE NO. 19-12-50,  
ADOPTED DECEMBER 16, 2019, ENTITLED, "AN ORDINANCE CALLING FOR A PUBLIC  
HEARING AND A JOINT REVIEW BOARD MEETING TO CONSIDER THE DESIGNATION  
OF A REDEVELOPMENT PROJECT AREA AND THE APPROVAL OF A REDEVELOPMENT  
PLAN AND PROJECT FOR THE VILLAGE OF CLARENDON HILLS [DOWNTOWN TAX  
INCREMENT FINANCING DISTRICT]", AND RATIFYING AND APPROVING THE  
RESCHEDULING OF THE JOINT REVIEW BOARD MEETING AND THE PROVIDING OF  
NOTICE RELATIVE TO SAID RESCHEDULED MEETING**

**WHEREAS**, on December 16, 2019, the President and Board of Trustees of the Village of Clarendon Hills (the "Village") adopted Ordinance No. 19-12-50, entitled "An Ordinance Calling For A Public Hearing And A Joint Review Board Meeting To Consider The Designation Of A Redevelopment Project Area And The Approval Of A Redevelopment Plan And Project For The Village Of Clarendon Hills [Downtown Tax Increment Financing District]" (the "Original Ordinance"); and

**WHEREAS**, as a result of an issue in regard to the amount of postage that was placed on the Joint Review Board meeting/Public Hearing notices, that were mailed out to the Taxing Districts impacted by the proposed Clarendon Hills Downtown Tax Increment Financing District and the Illinois Department of Commerce and Economic Opportunity on December 19, 2019, the Joint Review Board meeting needed to be rescheduled from Tuesday, January 7, 2020, at 3:00 p.m., at the Clarendon Hills Village Hall, Board Room, 1 North Prospect Avenue, Clarendon Hills, Illinois 60514, to Tuesday, January 14, 2020, at 3:00 p.m., at the Clarendon Hills Village Hall, Board Room, 1 North Prospect Avenue, Clarendon Hills, Illinois 60514; and

**WHEREAS**, proper notice of the rescheduled Joint Review Board meeting and Public Hearing was given on December 30, 2019, with the proper amount of postage thereon, to the Taxing Districts impacted by the proposed Clarendon Hills Downtown Tax Increment Financing District and the Illinois Department of Commerce and Economic Opportunity; and

**WHEREAS**, the Joint Review Board for the proposed Clarendon Hills Downtown Tax Increment Financing District did meet on January 14, 2020; and

**WHEREAS**, the President and Board of Trustees desire to ratify and approve the rescheduling of the Joint Review Board meeting, for the proposed Clarendon Hills Downtown Tax Increment Financing District, and amend the Original Ordinance in relation thereto;

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Clarendon Hills, DuPage County, Illinois, as follows:

**SECTION 1:** That the recitals set forth above are hereby incorporated herein.

**SECTION 2:** That Section 4 of the Original Ordinance is amended by revising the reference therein to "January 7, 2020" to read "January 14, 2020".

**SECTION 3:** That Exhibit C to the Original Ordinance is amended by revising the reference therein to "January 7, 2020" to read "January 14, 2020".

**SECTION 4:** That all other provisions of the Original Ordinance, not amended hereby, shall remain in full force and effect.

**SECTION 5:** That the rescheduling of the Joint Review Board meeting to Tuesday, January 14, 2020, at 3:00 p.m., at the Clarendon Hills Village Hall, Board Room, 1 North Prospect Avenue, Clarendon Hills, Illinois 60514, and the mailing of the notices of said rescheduled Joint Review Board meeting on December 30, 2019, are hereby ratified and approved.

**SECTION 6:** That this Ordinance shall be in full force and effect from and after its adoption and approval as provided by law.




